ALCOHOL PERMIT

The State of North Carolina requires that a permit be obtained when alcoholic beverages will be consumed. The Town of Tryon can issue a "Special Occasion" permit for those consuming alcoholic beverages at ROGERS PARK. The Town wants everyone who should rent ROGERS PARK to enjoy themselves and to have a safe return home.

GUIDELINES OF PERMIT

Please read the following guidelines and acknowledge, should alcohol be consumed.

\*Consume alcohol wisely - *do not become intoxicated.*

- \$50.00 permit fee

- Be at least 21 years of age

- Possess a valid drivers license

- Have person(s) monitor the party/occasion for disruptiveness, renters are responsible for the safety and welfare of their guests, as well as the ROGERS PARK.

- ABSOLUTELY!!! - no underage drinking will be allowed, all guests or participants must be 21 years of age - if underage drinking occurs it will result in the forfeiture of the privilege to rent ROGERS PARK and will result in the immediate dismissal of the party or occasion, with probable criminal charges against both the underage drinker and the permittee.

- To ensure the safety of the park and those utilizing these facilities, a law enforcement officer may survey the area during the hours of renting.
